

ORDINANCE NO. 28
OF THE BOARD OF SUPERVISORS
OF
EAST NORRITON TOWNSHIP
Montgomery County, Pa.

CREATING SEWER DISTRICT NO. 1 IN THE TOWNSHIP; DESIGNATING SAID SEWER DISTRICT AS THE PRESENT SEWER SERVICE AREA OF EAST NORRITON TOWNSHIP MUNICIPAL AUTHORITY AND AUTHORIZING THE CONSTRUCTION OF SEWERS THEREFOR AND THEREIN; GRANTING RIGHTS ON, OVER AND UNDER STREETS IN SAID DISTRICT

WHEREAS, by Ordinance No. 2 dated May 3, 1948, and by Resolution dated June 7, 1948, the Board of Supervisors of East Norriton Township created East Norriton Township Municipal Authority, all in accordance with the Municipality Authorities Act of May 2, 1945, P.L. 382, as amended; and

WHEREAS, under said Act the Authority has the power, inter alia, to acquire, hold, construct, improve, maintain, operate, own, lease, either as lessor or lessee, sewers, sewer systems or parts thereof for East Norriton Township and for such other territory as it may be authorized to serve; and

WHEREAS, the Board of Supervisors now wishes to designate and create a sewer district in the Township, which is also to be the present sewer service area of the Authority, and to authorize the Authority to construct sewers therein;

NOW, THEREFORE, the Board of Supervisors of East Norriton Township, Montgomery County, Pa., hereby ordains and enacts that:

Section 1. There is hereby created in East Norriton Township a sewer district, to be known as East Norriton Sewer District No. 1, to be bounded according to a plan dated August, 1959, prepared by Albright & Friel, Consulting Engineers, Philadelphia, Pa., copies of which plan and description of the real estate encompassed in said sewer district are on file and may be examined at the Township Municipal Building, 2828 Swede Road, Norristown, Montgomery County, Pa.

Section 2. The said East Norriton Sewer District No. 1 is hereby designated as the sewer service area of East Norriton Township Municipal Authority and the said Authority is authorized and directed to construct sewers for and in East Norriton Sewer District No. 1.

Section 3. The Township hereby grants to the Authority all and every easement, right of way and other rights necessary or desirable on, over or under the streets within East Norriton Sewer District No. 1 for the purpose of constructing sewers therein.
