

**ORDINANCE NO. 536
EAST NORRITON TOWNSHIP
MONTGOMERY COUNTY, PENNSYLVANIA**

**AN ORDINANCE OF THE TOWNSHIP OF EAST NORRITON RE-NUMBERING
CERTAIN BUILDINGS LOCATED ALONG BARBARA DRIVE**

WHEREAS, §1520 of the Second Class Township Code, *as amended*, and found at 53 P.S. 66520, entitled “Numbering of buildings”, authorizes the Board of Supervisors to regulate the numbering of buildings by ordinance, and,

WHEREAS, the Board of Supervisors for the Township of East Norriton deems it be in the best interest and general welfare of the citizens and residents of the Township to re-number a portion of Barbara Drive to accommodate a two-lot subdivision and to detail the penalties for those property owners who do not comply with the following ordinance, and,

WHEREAS, the Board of Supervisors of the Township of East Norriton has met the procedural requirements of 53 P.S. §66601, *et. Seq.* of the Second Class Township Code, for the adoption of the proposed ordinance, and,

WHEREAS, the Board of supervisors of the Township of East Norriton, after due consideration of the proposed ordinance at a duly advertised public meeting, has determined that the health, safety, and general welfare of the residents of East Norriton will be served by providing for the following amendments and enacting provisions related thereto.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Supervisors of the Township of East Norriton and it is hereby ordained and enacted by the authority of the same, to wit:

SECTION 1. BARBARA DRIVE RE-NUMBERING:

In accordance with the Second Class Township Code, §1520, 53 P.S. §66520, the Board of Supervisors hereby amends the street numbering of a portion of the buildings on Barbara Drive in accordance with the table below:

SECTION 2. PENALTIES:

Any person violating the provisions of this ordinance shall, upon conviction thereof before a District Justice having jurisdiction, be guilty of a civil offense and shall be punishable for each continuing offense by a fine of Six Hundred Dollars (\$600.00); provided further that each day’s continuance of the violation shall constitute a separate prosecutable offense. The Township may also pursue any other legal actions, including equity actions, against any person violating this ordinance.

SECTION 3. REPEALER:

All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed, it being understood and intended that all ordinances and the Code of the Township of East Norriton Pennsylvania, such as are not otherwise specifically in conflict or inconsistent with this ordinance, shall remain in full force and effect, the same being reaffirmed hereby.

SECTION 4. REVISIONS:

The Township Board of Supervisors does hereby reserve the right, from time to time, to adopt modifications of, supplements to, or amendments of its ordinance, including this provision.


SECTION 5. SEVERABILITY:

If any sentence, clause, section, term, phrase or part of this ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, terms, provisions, or parts of this ordinance. It is hereby declared the intent of the Board of Supervisors of the Township of East Norriton that this ordinance would have been adopted had such an unconstitutional, illegal, or invalid sentence, clause, section, or part thereof not been included herein.

SECTION 6. EFFECTIVE DATE:

This Ordinance shall be effective on August 1, 2011.
