

ORDINANCE NO. 158

East Norriton Township
Montgomery County, Pennsylvania

AN ORDINANCE EXPANDING SEWER DISTRICT NO. 1 IN EAST NORRITON TOWNSHIP; DESIGNATING SAID SEWER DISTRICT AS A SEWER SERVICE AREA OF THE EAST NORRITON TOWNSHIP MUNICIPAL AUTHORITY AND AUTHORIZING THE CONSTRUCTION OF SEWER THEREFOR AND THEREIN AT THE DISCRETION OF THE EAST NORRITON TOWNSHIP MUNICIPAL AUTHORITY; GRANTING RIGHTS ON, OVER AND UNDER STREETS IN SAID DISTRICT.

WHEREAS, by Ordinance No. 2 dated May 3, 1948 and by Resolution dated June 7, 1948, the Board of Supervisors of East Norriton Township created the East Norriton Township Municipal Authority, all in accordance with the Municipal Authorities Act of May 2, 1945; and

WHEREAS, the Board of Supervisors by Ordinance No. 28 designated and created Sewer District No. 1 within East Norriton Township; and

WHEREAS, the Board of Supervisors deems it advisable to expand the service area of the East Norriton Township Municipal Authority to encompass the entire Township.

NOW, THEREFORE, the Board of Supervisors of East Norriton Township, Montgomery County, hereby ordains and enacts as follows:

Section 1. Sewer District No. 1 is hereby expanded to encompass the entire Township of East Norriton.

Section 2. The entire Township of East Norriton is hereby designated as a sewer service area of the East Norriton Township Municipal Authority and the said Authority is authorized and directed to own, operate, maintain and construct sewers for and in the entire Township of East Norriton.

Section 3. East Norriton Township hereby grants to the Authority all and every easement, right of way and other rights necessary or desirable on, over or under the streets within the Township of East Norriton for the purpose of constructing sewers therein and any easements acquired by the Township of East Norriton for the purpose of constructing sanitary sewer lines.

Section 4. The appropriate officials of East Norriton Township are hereby authorized to enter into such agreements as are necessary to effectuate the intent of this Ordinance.

Section 5. Ordinance No. 107 is hereby repealed in its entirety.
