

ORDINANCE NO. 278
East Norriton Township
Montgomery County, PA

AN ORDINANCE PROVIDING FOR REIMBURSEMENT OF COSTS AND EXPENSES TO EAST NORRITON TOWNSHIP BY CONTRACTORS AND OTHER USERS OF INSPECTION, LOCATION AND OTHER SIMILAR SERVICES PROVIDED BY OR ON BEHALF OF EAST NORRITON TOWNSHIP.

WHEREAS, East Norriton Township, through its Building Inspector, Plumbing Inspector, and other employees and outside sources, obtains and provides services to contractors and other users, including, without limitation, those relating to the inspection, location and/or placement of water, electric, gas and communication lines, as well as other improvements, and also provides other inspection, location and/or placement related services for contractors and other users; and

WHEREAS, East Norriton Township has determined that such contractors and users should, to the extent permitted by law, be responsible for the payment to East Norriton Township of its expenditures and expenses for the above services, including without limitation expenditures to third parties and expenses of East Norriton Township for its Building Inspector, Plumbing Inspector and other employees providing such services.

NOW, THEREFORE, the Board of Supervisors of East Norriton Township, Montgomery County, Pennsylvania, under and by virtue of the authority granted by the Second Class Township Code, do hereby enact and ordain:

SECTION 1.

All contractors and other users, except for certificated public utilities, for whom East Norriton Township, through its Building Inspector, Plumbing Inspector, other employees or through outside sources, receive inspection, location and/or placement services concerning the location or placement of water, electric, gas, communication and other similar utilities or improvements of any nature whatsoever, or who receive other inspection, location and/or placement services, shall, to the extent permitted by law, pay to East Norriton Township its costs and expenses incurred in connection with such services, within thirty (30) days of issuance by East Norriton Township of an invoice therefore. The costs and expenses of East Norriton Township shall be billed to the contractors and users at the cost thereof to the Township, as either invoiced to East Norriton Township by outside sources, or, in the event such charges result from employees' services, at their hourly rate, as determined from time to time by the Board of Supervisors.

SECTION 2.

All ordinances, or parts thereof, inconsistent with this Ordinance are hereby repealed. Ordinance No. 273 is hereby repealed in full.

SECTION 3.

The provisions of this Ordinance are severable, and if any of its provisions shall be held to be illegal, invalid or unconstitutional by any court or administrative or governmental agency of competent jurisdiction, the remaining provisions of this Ordinance shall not be affected or impaired.

SECTION 4.

This Ordinance shall become effective five (5) days from the date hereinafter set forth.
