

ORDINANCE NO. 307

## EAST NORRITON TOWNSHIP

## MONTGOMERY COUNTY, PENNSYLVANIA

AN ORDINANCE AMENDING THE CODE OF EAST NORRITON TOWNSHIP, CHAPTER 196 ENTITLED VEHICLES AND TRAFFIC, BY ADDING CERTAIN STOP SIGN LOCATIONS AND CORRECTING THE POSITION OR DIRECTION OF TRAVEL FOR OTHER LOCATIONS AND DELETING ONE LOCATION IN SECTION 196-49.

The Board of Supervisors of East Norriton Township, Montgomery County, Pennsylvania under and by virtue of authority granted by the Second Class Township Code, does hereby enact and ordain:

**SECTION 1.**

The East Norriton Township Code is hereby amended as follows:

§196-49. Schedule VIII: Stop Intersections is amended by adding the following stop sign locations with the direction of travel and the intersecting road:

Eisenhower Road	North/South	Woodland Avenue
Elizabeth Drive	East	Old Arch Road
Faith Drive	North	Faith Drive
Faith Drive	South	Sandra Lane
Greenhill Lane	North	Township Line Road
Irenic Court	North	Woodland Avenue
James Circle	North	Woodland Avenue
Second Street	North/South	Francis Avenue
Scenic Road	North/South	Germantown Pike
Stanbridge Street	North/South	Timberlake Entrance
Woodland Avenue	East/West	Irenic Court
Woodland Avenue	East/West	Eisenhower Road

§196-49. is further amended by making the corrections to existing entries as set forth below:

A. The entry for Swede Road with an intersection with Francis Avenue should be amended to read "stop sign on: Francis Avenue; direction of travel: west; at intersection of: Swede Road".

B. The directions of travel for the following entries are hereby amended as follows:

STOP SIGN ON	DIRECTION OF TRAVEL	AT INTERSECTION OF
Rahway Avenue	North/South	Bristol Avenue
Rahway Avenue	North/South	Hazleton Avenue
Rahway Avenue	South	Johnson Highway
Kelly Drive	East	Sunset Avenue
Marion Avenue	West	Whitehall Road

C. The entry for New Hope Street with an intersection at Old Arch Road should be deleted.

**SECTION 2. Severability.**

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such provision shall be separate, distinct, and independent and such holding shall not affect the validity of the remaining portions of this Ordinance.
