

ORDINANCE NO.392

**EAST NORRITON TOWNSHIP
MONTGOMERY COUNTY, PENNSYLVANIA**

**AN ORDINANCE AMENDING THE CODE OF EAST NORRITON TOWNSHIP,
CHAPTER 196, ENTITLED VEHICLES AND TRAFFIC, BY ADDING
SECTION 196-17.1 AND SECTION 196-52.1 REGULATING
“DO NOT ENTER” AREAS AND SIGNS.**

The Board of Supervisors of East Norriton Township, Montgomery County, Pennsylvania, under and by virtue of authority granted by the Second Class Township Code, does hereby enact and ordain:

SECTION 1.

The East Norriton Township Code is hereby amended by adding the following thereto:

Section 196-17.1 Do Not Enter Areas.

It shall be unlawful for the driver of any vehicle to enter any of the streets or parts of streets described in Schedule XVIII (Section 196-52.1) attached to and made a part of this Chapter.

Section 196-52.1 Schedule XVIII: Do Not Enter Areas.

In accordance with the provisions of Section 196-17.1, no driver of any vehicle shall enter any of the streets or parts of streets described below during the times and days set forth below.

Name of Streets	Restricted Days	Restricted Time
1. Washington Avenue at the intersection with Swede Street	Monday thru Friday	7:00 a.m. – 9:00 a.m.
2. Jefferson Avenue at the intersection with Swede Street	Monday thru Friday	7:00 a.m. – 9:00 a.m.
3. Adams Avenue at the intersection with Swede Street	Monday thru Friday	7:00 a.m. – 9:00 a.m.
4. DeKalb Blvd. at the intersection with DeKalb Pike	Monday thru Friday	4:00 p.m. – 6:00 p.m.

SECTION 2. SEVERABILITY. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such provision shall be separate, distinct, and independent and such holding shall not affect the validity of the remaining portions of this Ordinance.

SECTION 3. RATIFICATION. This Ordinance shall in no other way affect, amend or modify the said Zoning Ordinance contained in Chapter 196 of the Code of East Norriton Township.
