**ORDINANCE NO. 532**

AN ORDINANCE OF THE TOWNSHIP OF EAST NORRITON, MONTGOMERY COUNTY, PENNSYLVANIA, AMENDING THE EAST NORRITON TOWNSHIP CODE, SPECIFICALLY, CHAPTER 168 STREETS AND SIDEWALKS.

WHEREAS, §1506 of the Second Class Township Code, as amended, and found at 53 P.S. 66506, entitled "General Powers", authorizes the Township Board of Supervisors to make and adopt ordinances, bylaws, rules and regulations, not inconsistent with or constrained by the Constitution and the laws of the Commonwealth necessary for the proper management, care, and control of the Township and the maintenance of the peace, good government, health, and welfare of the Township and its citizens.

NOW, THEREFORE, BE IT ENACTED and ORDAINED by the Board of Supervisors of East Norriton Township and it is hereby ordained and enacted by the authority of the same, to wit:

**SECTION 1. CODE AMENDMENTS**

**ARTICLE II, §168-8.C, Placement of snow; fire hydrants,** is hereby deleted and replaced with the following:

§168-8.C           It shall be unlawful for any owner, agent, tenant, occupant or person in charge of a property within the Township to throw, shovel, push or plow snow into, across or upon any road, street, sidewalk or right-of-way in the Township.

**ARTICLE II, §168-14.B, Violations and penalties,** is hereby amended by changing the fine amount specified within the paragraph from \$20 to \$30.

**SECTION 2. SEVERABILITY**

In the event that any section, sentence, clause, phrase or word of this ordinance shall be declared illegal, invalid or unconstitutional by any Court of competent jurisdiction, such declaration shall not prevent, preclude or otherwise foreclose enforcement of any of the remaining portions of this ordinance.

**SECTION 3. REPEALER**

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed.

**SECTION 4. SAVINGS CLAUSE**

If any provision of this Ordinance is declared by a court of competent jurisdiction to be invalid or unconstitutional, such determination shall have no effect on the remaining provisions of this Ordinance or on the provisions of the Code of Ordinances of East Norriton Township.

**SECTION 5. NO WAIVER**

The failure of East Norriton Township to enforce any provision of this ordinance shall not constitute a waiver by East Norriton Township of its rights of future enforcement hereunder.

**SECTION 6. EFFECTIVE DATE**

This ordinance shall become effective five days after its adoption by the East Norriton Township Board of Supervisors.
