ORDINANCE NO. 557

AN ORDINANCE OF EAST NORRITON TOWNSHIP, MONTGOMERY COUNTY, PENNSYLVANIA, AUTHORIZING THE TOWNSHIP TO ENTER INTO AN INTERGOVERNMENTAL REIMBURSEMENT AGREEMENT WITH THE MUNICIPALITY OF NORRISTOWN AND WEST NORRITON TOWNSHIP TO SHARE IN THE COST OF THE PURCHASE OF A COMPOST TURNER THAT WILL BE PAID FOR BY FUNDS SECURED FROM THE MUNICIPAL RECYCLING PROGRAM GRANT THROUGH THE PENNSYLVANIA DEPARTMENT OF ENVIRONMENTAL PROTECTION; REPEALING ALL INCONSISTENT ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Board of Supervisors of East Norriton Township, the Municipality of Norristown Council, and the Board of Commissioners of West Norriton Township have determined that it is in the best interests of the health, safety and welfare of their residents and the general public to collectively seek, through East Norriton Township's application, funds from the Municipal Recycling Program Grant (hereinafter, the "Grant") issued by the Pennsylvania Department of Environmental Protection (hereinafter, the "DEP") for the purchase of a Compost Turner (hereinafter, the "Equipment"); and

WHEREAS, the Townships and the Municipality have entered into an Intergovernmental Reimbursement Agreement (hereinafter, the "Agreement") wherein East Norriton Township will apply for the Grant from the DEP for the purchase of the Equipment, and the Townships and the Municipality will equally share in the cost of the Equipment as outlined in the Agreement; and

WHEREAS, the Pennsylvania Intergovernmental Cooperation Act requires that a municipality enact an ordinance authorizing entering into an intergovernmental cooperation agreement; and

WHEREAS, the Board of Supervisors of East Norriton Township desires to authorize the Township to enter into the Agreement with the Municipality of Norristown and West Norriton Township regarding the purchase of the Equipment;

NOW, THEREFORE, be it, and it is hereby **ORDAINED** by the Board of Supervisors of East Norriton Township, and it is hereby **ENACTED** and **ORDAINED** by authority of same as follows:

- i. The Agreement between East Norriton Township, the Municipality of Norristown, and West Norriton Township, a copy of which is attached hereto and incorporated herein by reference, is hereby approved, and the Chairman of


the Board of Supervisors and the Township Manager are hereby authorized to execute the Agreement.

- II. All ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed to the extent of the inconsistency.
- III. The provisions of this Ordinance are declared to be severable. If any provision of this Ordinance is declared by a court of competent jurisdiction to be invalid or unconstitutional, such determination shall have no effect on the remaining provisions of this Ordinance.
- IV. This Ordinance shall become effective five (5) days following its legal enactment.


