That a tax be and the same is hereby levied on all real property within the TOWNSHIP OF EAST NORRITON subject to taxation for the fiscal year 2002, as follows: Township, Home Rule Municipality

Tax rate for general purposes, the sum of .44 mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.

For debt purposes, the sum of .27 mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.

For Street Lighting purposes, the sum of .03 mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.

For Fire Protection purposes, the sum of .218 mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.

For Parks & Recreation purposes, the sum of .19 mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.

For Capital Reserve purposes, the sum of .296 mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.

For Ambulance Squad purposes, the sum of _____ mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.

For _____ purposes, the sum of _____ mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.
