**A RESOLUTION OF THE BOARD OF SUPERVISORS OF EAST NORRITON TOWNSHIP RATIFYING THE DEDICATION OF A ROAD OR ROADS AS PUBLIC ROADS OR STREETS IN THE TOWNSHIP OF EAST NORRITON**

**WHEREAS**, D’Arcangelo Builders, Inc., the owner and developer of a subdivision known as Fox Hunt had offered Deeds of Dedication to East Norriton Township Board of Supervisors for acceptance and dedication of the public streets contained in the Fox Hunt Subdivision as shown on the plan attached herein and made a part hereof as Exhibit “A”.

**WHEREAS**, the Board of Supervisors of East Norriton Township accepted the dedication of those streets pursuant to Deeds of Dedication dated November 10, 1998 with a recording date of February 8, 1999 which is attached hereto and made a part as Exhibit “B” for the streets in the subdivision as follows:

Old Arch Road (Parcel No. 33-00-90097-005);

Marielle Lane (Parcel No. 33-00-90101-001);

New Hope Street (Parcel No. 33-00-90109-002); and

Megann Court (Parcel No. 33-00-90105-006).

**WHEREAS**, the Township desires to ratify the Dedication of the streets in the Fox Hunt Subdivision.

**NOW, THEREFORE**, be it resolved, that the Dedication of the streets known as **Old Arch Road, Marielle Lane, New Hope Street and Megann Court** pursuant to the attached

Deeds of Dedication entered into between the Grantor, D'Arcangelo Builders, Inc. and the Grantee, East Norriton Township, is hereby ratified.

The Deeds of Dedication have been recorded in the Office of the Recorder of Deeds of Montgomery County and a copy of this Resolution with a copy the Deeds of Dedication and the Fox Hunt Subdivision plan shall be filed in the Office of the Clerk of Courts of the Court of Common Pleas of Montgomery County in accordance with our Article XI, Section 1140 of the Act of May 1, 1933, PL 103, as amended, 53 PS §66140 et seq.
