TAX LEVY RESOLUTION

RESOLUTION NO. 2125

A RESOLUTION OF THE Home Rule Municipality of EAST NORRITON TOWNSHIP OF EAST NORRITON County of MONTGOMERY, Commonwealth of Pennsylvania, fixing the tax rate for the year 2004.

BE IT RESOLVED AND ENACTED, and it is hereby resolved and enacted

by the Governing Body of Home Rule Municipality of the Board of Township Supervisors of the Township of EAST NORRITON County of MONTGOMERY, Commonwealth of Pennsylvania:

That a tax be and the same is hereby levied on all real property within the TOWNSHIP OF EAST NORRITON subject to taxation for the fiscal year 2004, as follows: Township, Home Rule Municipality

Tax rate for general purposes, the sum of .742 mills on each dollar of assessed valuation, or the sum of cents on each one hundred dollars of assessed valuation.

For debt purposes, the sum of .270 mills on each dollar of assessed valuation, or the sum of cents on each one hundred dollars of assessed valuation.

For Street Lighting purposes, the sum of .030 mills on each dollar of assessed valuation, or the sum of cents on each one hundred dollars of assessed valuation.

For Fire Protection purposes, the sum of .218 mills on each dollar of assessed valuation, or the sum of cents on each one hundred dollars of assessed valuation.

For Recreation purposes, the sum of .259 mills on each dollar of assessed valuation, or the sum of cents on each one hundred dollars of assessed valuation.

For Capital Reserve purposes, the sum of .418 mills on each dollar of assessed valuation, or the sum of cents on each one hundred dollars of assessed valuation.

For purposes, the sum of mills on each dollar of assessed valuation, or the sum of cents on each one hundred dollars of assessed valuation.
