**RESOLUTION NO. 2170**

EAST NORRITON TOWNSHIP  
MONTGOMERY COUNTY, PENNSYLVANIA

A RESOLUTION SETTING A SCHEDULE OF FEES FOR ZONING, LAND DEVELOPMENT, SUBDIVISION, BUILDING, PLUMBING, FIRE AND OTHER ASSOCIATED CHARGES IN THE TOWNSHIP OF EAST NORRITON, MONTGOMERY COUNTY.

WHEREAS, the Board of Supervisors of East Norriton Township wishes to set forth the schedule of fees for zoning, subdivision, land development, building permits, plumbing permits, fire code permits, highway occupancy escrows and permits, subdivision and land development escrows within one comprehensive document; and

WHEREAS, the Schedule of Fees must as nearly as possible reflect actual costs; and

WHEREAS, certain fees no longer reflect actual costs.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of East Norriton Township that Resolutions Numbered 1322, 1323, 1324, 1329, 1394, 1581, 1674, 1747, 1776, 1788 AND 2078 are rescinded and superseded by the following schedule of fees:

ZONING/SUBDIVISION/LAND DEVELOPMENT MATTERS

Adopted in accordance with East Norriton Township Zoning Ordinance No. 96, as amended, and the Subdivision and Land Development Ordinance, as amended and being Chapter 175 of the East Norriton Township Code.

1. Application for Change of Zoning (Revision to Zoning Map, curative amendment, or challenges):

A non-refundable fee .....\$ 1000.00

NOTE: An escrow deposit of \$1,000 per acre of land up to \$5,000 must be paid at the time of application. The escrow will be used to pay all consultant or other review fees associated with the application.

2. Traffic Impact per P.M. Peak Hour Trip.....\$947/PMPHT

3. Application for a Hearing Before the Zoning Hearing Board (Requesting a variance or special exception; appealing a decision of the Zoning Officer):

Residential (AR, BR, CR, MR, RR Zoning Districts) .....\$200.00

All others .....\$500.00

**(Multiply residential lots under common ownership \$50.00/lot)**

- 4. Attached Accessory Structure Permit (under 500 sf).....\$ 75.00
- 5. Use and Occupancy Permits:
  - e. Residential (New Dwelling) .....\$100.00
  - f. Residential Resale (existing structure).....\$ 50.00
  - g. Residential Alteration creating new occupiable space .....\$ 50.00
  - h. All Others - The greater of \$100.00 per individual unit of occupancy and use or, \$3.00 for every 100 square feet or fraction thereof of the total area involved. Applies to change of use, occupancy or ownership.
  - e. Reinspections (**after second inspection**).....\$ 25.00  
(This fee will be charged for failure to comply with written correction requirements after first reinspection)
  - f. Home Occupation.....\$ 100.00/yr

NOTE: The aggregate of common area in buildings that will house more than one occupancy is considered as a separate individual unit for determining cost.

- 6. Sign Permits:
  - a. Value up to \$250.00 .....\$ **50.00**
  - b. Value of \$250.00 and over .....\$ 50.00  
(plus **\$10.00** for each additional \$100.00 of value or fraction thereof)
  - c. Temporary permits (except political).....\$ 30.00/wk

Subdivision or Land Development

- 1. Application fee (land development/subdivision).....\$500.00 plus \$25.00/per lot

An **Applicant shall execute a contract for professional services** and deposit \$5,000.00 escrow to be paid at the time of application for all subdivisions or land developments except residential subdivisions that create no more than two lots or those that adjust residential lot lines for no more than three lots with no public improvements involved. The required escrow for these subdivision applications will be \$1000.00. The escrow will be used to pay all engineering, legal or other review fees associated with the application.

An escrow is required if the following work has not been completed before the time of issuance of the use and occupancy permit:

- a. Grading and seeding.....\$ 750.00
- b. Wearing Course on Driveway.....\$ 750.00
- c. On-Lot Erosion Control (per lot).....\$1000.00

4. Developer's Agreement Escrow

The applicant shall establish an escrow to cover legal, engineering and professional consultant fees in the total amount of 15% of the estimated cost of improvements or an amount agreeable to the Township. This amount shall be calculated prior to addition of the 10% retainage to the cost of improvements per MPC.

TOWNSHIP FEES

**ALL FEES REQUIRED BY THE TOWNSHIP SHALL BE PAID PRIOR TO ISSUANCE OF BUILDING PERMITS.**

The applicant for a Building/Construction Permit shall, at the time of securing such a permit, pay to the Township, the required fee, for each and every building or addition, alteration, repair, moving, shoring or razing of any building or structure, in accordance with the following:

1. Buildings/Structures

- A. **Permit Late Fee (not obtaining permit prior to start of work).....\$ 25.00**
- B. **Pennsylvania Education Fee.....\$ 2.00**
- C. **Building Code Appeals Board Application.....\$1000.00**
- D. Footings - Issued only at Township's discretion. Work must stop at grade level.  
  
Residential/Commercial Footings.....\$ 50.00 per 100 lineal feet of perimeter  
( In addition to building permit fee.)
- E. **Buildings Permit Fees: Including additions, decks, sunrooms, patio roofs, ect.**
  - 1. **Residential per square feet.....\$ 0.20 (\$ 75.00 Min)**
  - 2. **Commercial per square feet .....\$ 0.30 (\$100.00 Min)**

Residential square footage to include 100% living space, 50% of nonliving space - attic, garages, unfinished basements, etc.

Calculated area for unfinished spaces such as warehouses or unfinished building shells in Commercial, Industrial, and Institutional buildings shall be based on 50% of actual square footage.

- F. Accessory Buildings: Sheds and detached garages
  - 1. Residential per 250 square feet or fraction thereof.....\$ 25.00
  - 2. Commercial per 250 square feet or fraction thereof.....\$ 50.00

G. Demolition:

- 1. Residential per square foot ..... \$ 0.15 (\$ 25.00 Min)
- 2. Commercial per square foot.....\$ 0.20 (\$ 50.00 Min)

H. Reviews:

- A. Building Plans per square foot.....\$ 0.05 (\$ 25.00 Min)
- B. Accessibility Review.....\$ 0.02 (\$ 25.00 Min)
- C. Energy Review.....\$ 0.03 (\$ 25.00 Min)
- D. Fire Plan Review .....\$ 50.00

(The Township reserves the right to require outside plan review which cost will be added the Township's permit cost)

I. Swimming Pool - Ordinance #178

- 1. Residential per \$1000 or fraction thereof.....\$ 25.00
  - 2. Commercial per \$1000 or fraction thereof.....\$ 50.00
- (20 foot set back to water line requirement from side or rear property lines)  
(A heater for the pool requires a separate Fire Permit)

J. Replacement Windows

- 1. Residential \$5.00 each, \$25.00 minimum
- 2. Commercial \$5.00 each, \$50.00 minimum

K. Roofing, Siding, Stone, Stucco, Brick.....\$ 3.50/Square (\$ 50.00 Min)

L. Installation, enlargement or overlay of new or existing driveway or parking lot

- 1. Residential.....\$ 30.00
- 2. Non-Residential.....\$ 100.00

M. Curb or Sidewalks or Driveway Aprons (except new developments)

- 1. Per 100 lineal feet .....\$ 25.00
- 2. Restoration escrow of roadway for curb.....\$ 7.00

N Street opening permits shall be in accordance with the fee schedule established by the Pennsylvania State Association of Township Supervisors made part of this schedule and escrow for street openings shall be a minimum of \$500.00 held for two years after final restoration (When work on performed on state highways, the fee will be established accordingly)

- O. Grading or storm water permit \$25.00 plus cost of Township Engineer review
  
- P. HVAC Permits
  - 1. Residential new system.....\$ 50.00
  - 2. Residential replacement.....\$ 25.00
  - 3. Commercial new system.....\$ 25.00/ton or **100K BTU**
  - 4. Commercial replacement.....\$ 15.00/ton or **100K BTU**
  - 5. Residential alteration.....\$ 25.00/unit
  - 6. Commercial alteration.....\$ 50.00/unit
  - 7. **Installation or Alteration Gas Piping (pool heaters/grills, ect)....\$ 25.00**
  
- Q. Plumbing Permits
  - 1. Install New per Fixtures
    - A. Residential.....\$ 20.00
    - B. Commercial.....\$ 30.00
  
  - 2. Replacement per Fixture
    - A. Residential.....\$ 10.00
    - B. Commercial.....\$ 20.00
  
  - 3. Water Softener or Water Heater .....\$ 10.00
  
  - 4. Sewer Ejector or Interceptor (grease, hair, oil, etc.).....\$ 25.00
  
  - 5. Garbage Disposal .....\$ 10.00
  
  - 6. Installation or Alteration of Outdoor Water or Gas Piping
    - A. Residential .....\$ 25.00
    - B. Commercial.....\$ 50.00
  
  - 7. New Water Service or Sewer Lateral Installation or Repair
    - A. Residential.....\$ 25.00
    - B. Commercial per 100 lf.....\$ 25.00
  
  - 8. Storm Sewer Connection Inspection to Existing System
    - A. Residential.....\$ 25.00
    - B. Commercial.....\$ 50.00

- R. Registration
1. Master Plumber.....\$ 75.00
  2. Journeyman Plumber.....\$ 30.00
  3. Apprentice Plumber.....\$ 25.00
  4. Electrician per job.....\$ 25.00
  5. Contractor Annual.....\$ 75.00
- (All registrations are from January 1 to December 31)

All contractors working in East Norriton Township are required to be registered with the Township. The contractor shall supply the Township a copy of their liability and worker's compensation insurance coverage, naming East Norriton Township as an additional insured. Electrician's must also supply the name of the inspection company being used to perform inspections.

SANITARY SEWER TAPPING FEE

The applicant for a sanitary sewer connection shall be paid at the time of applying for a building permit to the Township, in accordance with the following:

- Tapping Fee on behalf of ENPWJSA.....\$1,800.00 (per EDU)  
(adopted by ENPWJSA on June 10, 1998)
- Tapping Fee - East Norriton Township .....\$3,260.00 (per EDU)
- Sewer Connection Inspection Fee .....\$ 250.00  
(connections to Township owned system)

FIRE CODE PERMIT FEES

The applicant for a Fire Code Permit shall, at the time of securing such a permit, pay the Township the required fee for each permit, in accordance with the following:
