Resolution No. 2318

A Resolution of the Township of East Norriton, Montgomery County, Commonwealth of Pennsylvania, United States of America.

APPROVING THE EAST NORRITON TOWNSHIP OPEN SPACE PLAN UPDATE 2005.

WHEREAS, under the provisions of the Pennsylvania Municipalities Planning Code, (MPC), Act 247 of July 31, 1968, as reenacted and amended, the Township of East Norriton is authorized to prepare and maintain plans for community facilities, public grounds, parks and recreation, pedestrian and bikeway systems; and

WHEREAS, Montgomery County has made certain monies available to East Norriton Township for the preparation of an Open Space Plan, as well as the acquisition of Open Space; and

WHEREAS, the Board of Supervisors of East Norriton Township originally authorized the preparation of a study of open space needs in the Township of East Norriton in 1994 which resulted in the adoption of the Township Open Space Plan through Resolution No. 1610 in December 1995; and

WHEREAS, an Open Space Committee comprised of Francis "Bud" Denner, Chairman, Daniel Delaney, Vice Chairman, Larry Brown, Secretary, James J. Serratore, Keith C. Tornetta, Shawn O'Rourke, Michael Stokes, Helmuth J.H. Baerwald and the Township Planner E. Van Rieker; and

WHEREAS, the Committee has completed the study and published its findings and recommendations in a document entitled "East Norriton Township Open Space Plan Update 2005"; and

WHEREAS, the said document was prepared based upon the results of a broad public participation process involving meetings and hearings and township wide mailings; and

WHEREAS, the said document has been reviewed and is considered to be compatible with the municipal objectives expressed in the 1994 East Norriton Township Comprehensive Plan and the Montgomery County Open Space Plan Board; and

WHEREAS, the East Norriton Township Open Space Committee has recommended that said document be adopted by the Board of Supervisors of East Norriton Township; and

WHEREAS, said document is a flexible document intended to serve as an overall policy guide for decisions that affect the provisions of open space and is to be periodically reviewed, updated and refined.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF EAST NORRITON TOWNSHIP on this 25th day of September 2006 accepts and adopts the document entitled The East Norriton Township Open Space Plan Update 2005, Montgomery County, Pennsylvania, including all maps, charts and textual matter.

BE IT FURTHER RESOLVED, that the recommendations of the said document shall serve as short-term and long-range objectives for the meeting of open space needs of East Norriton Township.




