RESOLUTION NO. 2432

A RESOLUTION OF THE Home Rule Municipality of _____, TOWNSHIP OF East Norriton, County of Montgomery, Commonwealth of Pennsylvania, fixing the tax rate for the year 2009.

BE IT RESOLVED AND ENACTED, and it is hereby resolved and enacted

by the Governing Body of Home Rule Municipality of the _____ of _____, Board of Township Supervisors of the Township of East Norriton, County of Montgomery, Commonwealth of Pennsylvania:

That a tax be and the same is hereby levied on all real property within the East Norriton Township subject to taxation for the fiscal year 2009, as follows: Township, Home Rule Municipality

Tax rate for general purposes, the sum of 1.102 mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.

For debt purposes, the sum of .27 mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.

For Recreation purposes, the sum of .326 mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.


For Street Lighting purposes, the sum of .03 mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.

For Fire Protection purposes, the sum of .218 mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.

For Capital Reserve purposes, the sum of .366 mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.

For _____ purposes, the sum of _____ mills on each dollar of assessed valuation, or the sum of _____ cents on each one hundred dollars of assessed valuation.
