

**RESOLUTION NO. 2587**

**EAST NORRITON TOWNSHIP  
MONTGOMERY COUNTY, PENNSYLVANIA**

**A RESOLUTION BY THE BOARD OF SUPERVISORS OF EAST NORRITON TOWNSHIP,  
COUNTY OF MONTGOMERY, COMMONWEALTH OF PENNSYLVANIA, AMENDING THE  
EAST NORRITON FEE SCHEDULE**

WHEREAS; by Resolution No. 2311, adopted July 25, 2006, the Board of Supervisors of East Norriton Township adopted a fee schedule; and

WHEREAS; by Resolution No. 2578 dated January 3, 2012, the fee schedule was reaffirmed; and

WHEREAS; the Board of Supervisors of East Norriton Township desires to amend the fee schedule to increase certain fees for zoning applications and residential resale use and occupancy permits.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of East Norriton Township, Montgomery County, that:

- 1) The Application / Appeal fee for a Public Hearing before the East Norriton Township Zoning Hearing Board for a variance, special exception, interpretation and/or an appeal of the determination of the Zoning Officer for properties located in the AR, BR, BR-1, CR, MR, RR, and ATR zoning districts, or for properties located in the RP and RO zoning districts that are occupied as single family dwellings is five hundred dollars (\$500.00).
- 2) The Application / Appeal fee for a Public Hearing before the East Norriton Township Board of Supervisors for a conditional use for properties located in the AR, BR, BR-1, CR, MR, RR, and ATR zoning districts, or for properties located in the RP and RO zoning districts that are occupied as single family dwellings is five hundred dollars (\$500.00).
- 3) The Application / Appeal fee for a Public Hearing before the East Norriton Township Zoning Hearing Board for a variance, special exception, interpretation and/or an appeal of the determination of the Zoning Officer for properties located in the HR, HR-1, RP, RO, IN, BP, EC, ECII, C, C-1, SC, I, LI, HI, and FP zoning districts is one thousand seven hundred fifty dollars (\$1,750.00).
- 4) The Application / Appeal fee for a Public Hearing before the East Norriton Township Board of Supervisors for a conditional use for properties located in the HR, HR-1, RP, RO, IN, BP, EC, ECII, C, C-1, SC, I, LI, HI, and FP zoning districts is one thousand seven hundred fifty dollars (\$1,750.00).
- 5) The Application fee for a Public Hearing before the East Norriton Township Board of Supervisors requesting a change of zoning is two thousand five hundred dollars (\$2,500.00).
- 6) The Application fee for a curative amendment or challenge to the validity of the East Norriton Township Zoning Ordinance is two thousand five hundred dollars (\$2,500.00).
- 7) The Application fee for a Residential Resale Use and Occupancy Permit is two hundred fifty dollars. (\$250.00).

- 8) All previously adopted fees for applications and appeals inconsistent with this Resolution are hereby repealed.
