**A RESOLUTION OF THE BOARD OF SUPERVISORS OF EAST NORRITON
TOWNSHIP, COUNTY OF MONTGOMERY, COMMONWEALTH OF
PENNSYLVANIA, AUTHORIZING A TEMPORARY INCREMENTAL SANITARY
SEWER BILLING SCHEDULE**

WHEREAS, East Norriton Township bills its property owners for sanitary sewer rents on a quarterly basis, determined by water usage reports provided by the Pennsylvania American Water Company; and

WHEREAS, the bills that residents currently receive, reflect charges for water use six (6) months prior; and

WHEREAS, as a result, the Township is forced to carry costs until residents are billed, residents are confused by the bills they receive, and when a home is being sold, owners are faced with paying off large sewer bills; and

WHEREAS, the Board of Supervisors understands the need to temporarily alter the Township's current billing structure in order to "catch-up" the billing cycle, while at the same time recognizes the importance of doing so in a way that results in the least financial burden to the residents.

NOW, THEREFORE, BE IT RESOLVED, that the East Norriton Board of Supervisors authorizes the Township Manager to proceed with the following temporary incremental billing schedule, also outlined below: property owners will receive three (3) consecutive quarterly bills, starting with July 1, 2013, that include the equivalent of four (4) months of sewer charges. After those three (3) billing cycles are completed, all future bills will revert back to covering three (3) months of sewer charges.

Temporary Incremental Sanitary Sewer Billing Schedule
