**EAST NORRITON TOWNSHIP

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF EAST NORRITON  
TOWNSHIP APPROVING THE BUDGET AND FIXING THE  
REAL ESTATE TAX RATE FOR THE YEAR 2015**

**WHEREAS**, the proposed 2015 Budget has been presented with the total revenues (all funds) of \$17,070,813 and total expenditures (all funds) of \$17,070,813; and

**WHEREAS**, a tax be and the same is hereby levied on all real property within East Norriton Township subject to taxation for the fiscal year 2015 as follows:

Tax rate for general purposes, the sum of ..... 1.447 mills  
on each dollar of assessed valuation, or the sum..... cents  
on each one hundred dollars of assessed valuation.

Tax rate for debt purposes, the sum of ..... .270 mills  
on each dollar of assessed valuation, or the sum..... cents  
on each one hundred dollars of assessed valuation.

Tax rate for recreation purposes, the sum of ..... .326 mills  
on each dollar of assessed valuation, or the sum..... cents  
on each one hundred dollars of assessed valuation.

Tax rate for street lighting purposes, the sum of ..... .030 mills  
on each dollar of assessed valuation, or the sum..... cents  
on each one hundred dollars of assessed valuation.

Tax rate for fire protection purposes, the sum of ..... .288 mills  
on each dollar of assessed valuation, or the sum..... cents  
on each one hundred dollars of assessed valuation.

Tax rate for capital reserve purposes, the sum of ..... .366 mills  
on each dollar of assessed valuation, or the sum..... cents  
on each one hundred dollars of assessed valuation.

The same being summarized in tabular form as follows:

Debt Purposes	.270
Recreation Purposes	.326
Street Lighting Purposes	.030
Fire Protection Purposes	.288
Capital Reserve Purposes	.366

That any resolution, or part of resolution, conflicting with this resolution be and the same is hereby repealed insofar as the same affects this resolution.

**NOW, THEREFORE, BE IT RESOLVED**, that the East Norriton Township Board of Supervisors hereby formally approves the 2015 Budget with the total revenues (all funds) of \$17,070,813 and total expenditures (all funds) of \$17,070,813 and the 2015 Real Estate Tax rate of 2.727 mills.
