TOWNSHIP AMENDING THE EAST NORRITON TOWNSHIP FEE SCHEDULE**

WHEREAS; the Township's existing fee schedule does not contain a provision for the establishment of a General Zoning Permit Fee and General Review Fee.


NOW, THEREFORE, BE IT RESOLVED, by the Board of East Norriton Township that the East Norriton Township 2016 Fee Schedule is hereby amended by adding the following fee amounts:

1. General Zoning Permit Fee: \$50.00
2. General Review Fee: \$25.00 (To be credited towards any building permit fees incurred)
3. Use Permit Fee: \$25.00 (To be credited towards any building permit fees incurred)



Use of portable hot work equipment inside a structure. Exception: Work that is conducted under a construction permit. 3. Fixed-site hot work equipment such as welding booths. 4. Hot work conducted within a wildfire risk area. 5. Application of roof coverings with the use of an open-flame device. 6. When approved, the fire code official shall issue a permit to carry out a hot work program. This program allows approved personnel to regulate their facility's hot work operations. The approved personnel shall be trained in the fire safety aspects denoted in this chapter and shall be responsible for issuing permits requiring compliance with the requirements found in Chapter 26. These permits shall be issued only to their employees or hot work operations under their supervision. 	\$50

105.6.31	<p>Open flames and torches - required to remove paint with a torch; or to use a torch or open-flame device in a wildfire risk area.</p>	\$50
