**A RESOLUTION OF THE TOWNSHIP OF EAST NORRITON, COUNTY OF
MONTGOMERY, COMMONWEALTH OF PENNSYLVANIA, APPROVING THE
TRANSFER OF RESTAURANT LIQUOR LICENSE NO. R-9349 INTO THE
TOWNSHIP OF EAST NORRITON**

WHEREAS, Act 141 of 2000 (“the Act”) authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of restaurant liquor licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section 461 of the Liquor Code if, as in the Township of East Norriton, sale of liquor and malt or brewed beverages are legal in the municipality receiving the license; and

WHEREAS, the Act requires the applicant to obtain from the receiving municipality a resolution approving the inter-municipal transfer of the liquor license prior to the applicant’s submission of an application to the Pennsylvania Liquor Control Board; and

WHEREAS the Liquor Code stipulates that, prior to a resolution by the receiving municipality, at least one hearing be held for the purpose of permitting individuals residing within the municipality to make comments and recommendations regarding applicant’s intent to transfer a liquor license into the receiving municipality; and

WHEREAS, an application for transfer filed under the Act contain a copy of the resolution adopted by the municipality approving the transfer of a liquor license into the municipality.

NOW, THEREFORE, BE IT RESOLVED, that Kabu East Norriton, Inc. has requested the approval of the Township of East Norriton Board of Supervisors for the proposed transfer of Pennsylvania restaurant liquor license no. R-9349 from Whipain Holdings LLC, 1486 Skippack Pike, PO Box 604, Worcester, Pennsylvania to Kabu East Norriton, Inc. for restaurant facilities within the Township of East Norriton to be located at 2640-2714 DeKalb Pike, Suite 111, East Norriton, Montgomery County, Pennsylvania, PA 19401 with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board; and

BE IT FURTHER RESOLVED, that the Township of East Norriton Board of Supervisors has held a properly advertised public hearing pursuant to the notice provisions of Section 102 of the Liquor Code to receive comments on the proposed liquor license transfer; and

BE IT FURTHER RESOLVED, that the Township of East Norriton approved, by adoption of this Resolution, the proposed inter-municipal transfer of restaurant liquor license no. R-9349 into the Township of East Norriton by Kabu East Norriton, Inc.; and

BE IT FURTHER RESOLVED, that transfers, designations and assignments of licenses hereunder are subject to approval by the Pennsylvania Liquor Control Board.


