TOWNSHIP ORGANIZATION

Board of Supervisors

East Norriton Township is a township of the second class under Pennsylvania State statutes. There are five elected officials called Supervisors, who serve staggered six-year terms. Chairperson and Vice-Chairperson are elected every January by their fellow Supervisors. They pass legislation and set the policy for the township.

The Board is responsible for the general governance of the township, including the execution of legislative, executive, and administrative powers to ensure sound fiscal management and secure the health, safety, and welfare of the citizens of East Norriton. They carry out these functions through township staff via the Township Manager, as well as various appointed citizen advisory boards, commissions, and councils. The Township Manager, along with the full and part-time employees, is responsible for day-to-day operations. The staff operates within six departments: Administration, Police, Finance, Public Works, Zoning & Code Enforcement, and Parks & Recreation.

Citizen Boards and Commissions

There are several commissions, boards, and authorities currently serving the township. They are comprised of appointed citizens who volunteer to assist in township government by advising, informing, and assisting the Board of Supervisors.

These citizen volunteers provide a valuable service to the township. More information about citizen boards and commissions can be found on the township website. TOWNSHIP DEPARTMENTS

Parks & Recreation Department

The East Norriton Township Parks and Recreation Department is dedicated to providing exciting activities to all the residents of East Norriton Township! We have an incredible offering of programs including bocce, pickleball, basketball, senior bingo and more! Residents can also purchase discount tickets for amusement parks and ski areas as well as discount movie tickets for are movie theaters!

We're also proud to present annual special events such as our community *Easter Egg Hunt*, *Memorial Day commemoration*, *Summer Concert Series*, *Summer Movies in the Park*, spectacular *Community Day*, *Trunk or Treat celebration* and *Holiday Tree Lighting Ceremony!*

East Norriton is also home to over 117 acres of open space including trails, educational areas, picnic space, basketball courts, playground equipment, all in addition to our Veterans Memorial and the historical Norris City Cemetery. The largest of these spaces are [Stanbridge Street Park](#), [Heroes Park](#), [Louis Mack Watson Park](#) and [Old Arch Road Park](#). All feature a variety of active recreational activities for residents and visitors!

Stanbridge Street Park offers the most amenities and is the host site for many our special events. The park features bocce courts, tennis/pickleball courts, an outdoor basketball court, lighted softball field and ADA accessible playground equipment! There is a one-mile paved walking trail that loops through our beautiful grounds and connects to the popular Norristown Farm Park trail. The park is home to Park is *The Clubhouse at Stanbridge Street Park* - an indoor meeting space used for small group recreation programs – and *The Pavilion* – a covered picnic area available for rental by township residents.

Public Works Department

The Public Works Department of East Norriton Township is responsible for maintaining all the roads (55 miles of roads!), 117 acres of open space/parks, stormwater, and municipal facilities within the Township.

Additionally, the department also oversees spring and fall leaf collection along with the Township's free monthly yard waste pickup service. These services are important components of the Township's extensive recycling program which features the area's only municipal Compost Site and utilizes specialty equipment like truck mount vacuum leaf collectors and commercial compost turners.

Building / Zoning / Code Enforcement Department

The Codes Department is committed to protecting the public's health and comfort and to promoting and maintaining a safe, clear and enjoyable township for all residents and visitors. The Department administers the Township's codes in addition to administering all applications pertaining to building permits, land development and zoning.

Code Enforcement Officers are charged with the enforcing property maintenance regulations within the Township. Distressed and poorly maintained properties quickly lose value and that reduced value is reflected in the value of adjacent properties. One of the greatest benefits of the implementation of a property maintenance inspection program is the ability to maintain property values throughout the Township.

The Codes Department is responsible for fire safety inspections of all types of occupied buildings and buildings under construction and renovation except for one-and two-family homes in the Township. The inspected buildings include schools, hospitals, nursing homes, day care centers, restaurants, businesses, stores and hotels. All of these buildings must be in compliance with the Township's Fire Code, the International Fire Code and NFPA. The department also interacts with the Fire Department on various items including advising the fire department of the hazards that the department may encounter in a fire or other incident.



Police Department

The East Norriton Township Police Department is committed to enhancing the quality of life in our community through our:

- Service to the public
- Protection of persons and property
- Impartial enforcement of the law
- Partnership with the community

We believe in an interactive process between police officers and the citizens who either reside, visit or work in the township of East Norriton; to mutually develop ways to identify problems and concerns and then respond to these problems utilizing a wide range of methods and resources available from the police department, other governmental entities, or the community itself. Our overall goal is to create a cooperative relationship between the police and residents to identify problems that impact the quality of life, to devise strategies to address those problems, and to work together to solve them.

We are committed to accountability at all levels, respect and honest communication with the community, and a desire to work with all members of the public to enhance the quality of life that makes East Norriton Township such a unique place to reside, visit and work. Finance Department

The Finance Department is responsible for all the financial management operations of the Township ensuring that all financial activities are conducted accurately and in conformance with Generally Accepted Accounting Principles. TAXES IN EAST NORRITON

REAL ESTATE (PROPERTY) TAXES

Real Estate taxes are collected by the Township's independently elected tax collector. Township property tax bills are mailed in March of each year and a discount is offered for early payment. More information about township property tax bill details and payment options can be found on the Township's website. School District property tax bills are mailed in June of each year and are completely separate from Township taxes. Please contact the Norristown Area School District for details and payment options about school district property tax bills.

LOCAL INCOME TAX

A local income tax is payable by all residents of East Norriton Township along with all non-residents who work in East Norriton Township. The rate is 1% with one-half going to the Township and one-half going to the school district. Most employers deduct this tax from employees' paychecks. In that case, all you do is file an annual return by April 15th of each year. If you are self-employed or work for an employer who does not deduct this tax, or only a portion of it, you are obligated to file quarterly returns. Berkheimer Associates is the appointed collector for this tax.

LOCAL SERVICES TAX

The Local Services Tax is payable by residents and non-residents, and employers are required to deduct the tax from employees' paychecks throughout the year based on the number of payroll periods during the year. The tax is \$52.00 per year. Berkheimer Associates is the appointed collector for this tax.

BUSINESS PRIVILEGE TAX

The Business Privilege tax is payable by all for-profit businesses located within or doing business within East Norriton Township. Also known as a gross receipts tax, the rate is based on the type of business (wholesale business rate is 0.1% and all others are 0.15%). Berkheimer Associates is the appointed collector for this tax.

LEAF & YARD WASTE COLLECTION

FALL LEAF COLLECTION

The Township collects leaves each fall for several weeks - please check the Township website for collection dates. Residents are expected to have at the curb by Monday morning and every effort will be made to have them collected by the end of business Friday. Our typical collection routine involves leaf vacuum crews working on the eastern and western ends of the Township and work towards the middle (North Wales Road area). There is no set schedule for leaf collection – and there is no need to call in for collection.

Please be reminded that leaf piles should be no larger than 18" high and 18" wide with no trash, tree limbs or other debris mixed with the leaves. All leaves must be placed in the street along the curb or at the edge of the roadway as township employees are not permitted to enter private property to rake leaves. Any delay in the schedule because of inclement weather will be carried out the following work day. Residents are asked not to park on the leaf piles as this hinders the leaf collection process and may cause fires.

YARD WASTE COLLECTION

The Township conducts a yard waste pickup on the 3rd Monday of each month. If the 3rd Monday is a Holiday, service will be provided on the next business day. Residents must register for a pickup which can be done on the Township website or by calling the Township at 610-275-2800.

Up to two days prior to the scheduled collection day, residents may set out yard waste using 32-gallon trash cans or bundles. Since the yard waste will be recycled, residents cannot set out yard waste in plastic bags, residents cannot set-out dirt, rocks, stumps, weeds, grass, bamboo or leaves. Trash cans used to set out yard waste must be clearly marked as yard waste. Each trash can or bundle cannot exceed 40 pounds and each bundle shall be no more than 3 foot in diameter, and/or 50 lbs; individual branches- maximum of 5-inch diameter placed at the curb with the cut ends of the yard waste towards the street. Branches, limbs, or trunks cannot be more than 5 inches in diameter. Yard waste properly containerized or bundled should be placed within 5 feet of the curb and in such a manner not to obstruct the road.



Yard waste improperly set-out or co-mingled with unacceptable materials will not be collected. East Norriton Township will collect up to 2 cubic yards of yard waste, approximately ten 32-gallon trash cans or six bundles, per household on each scheduled collection day. SNOW REMOVAL

PLOWING – Please remember to remove vehicles from Township roadways during a snow event. The best time to prepare is when a storm has been forecasted. Often times it is not snowing when we go to bed or leave in the morning, but we can wake up to or arrive home to a blanket of white. Once the Road Crews are dispatched out to clear the snow, any vehicles parked on roadways will be ticketed and possibly towed. You can read the Ordinance in detail by going to www.eastnorritontwp.org select Township Information Ordinance #565.

SHOVELING GUIDELINES – It is the responsibility of the property owner or the lessee to clear a pathway in the sidewalk not later than 24 hours after the snow has ceased to fall. The pathway should not be less than 30” in width and should be thoroughly cleaned of snow, ice or any other obstruction.

CLEARING FIRE HYDRANTS – Clearing snow away from fire hydrants is a very important responsibility. The fire department asks residents to clear a 36” path around hydrants to allow for access. If you join together with your neighbors, it only takes a few minutes to ensure the fire hydrants are clear of snow. Please take the few extra minutes needed to protect your home and family.

TRASH & RECYCLING

East Norriton Township does not have a municipal trash collection service. Rather, residents have the option to choose a trash hauler of their preference. It is recommended that you check with your neighbors to determine which trash hauler collects in your neighborhood. All residents and businesses shall have municipal waste collected by a municipal waste collector who is legally operating within the township, and collections shall be no less frequent than one time per week.

Per East Norriton Township Code, all residents and businesses must recycle. Residents of East Norriton shall separate recyclable materials from their municipal waste. When placed at the curb for collection, recyclable materials shall be placed in separate, reusable metal or plastic containers which clearly identify the contents as recyclables. Recycling bins may be available through your hauler, or they may be purchased at the expense of the property owner.

SANITARY SEWER SERVICE

Sewer service in East Norriton Township is provided by Aqua and regulate by the Pennsylvania Public Utility Commission. Please contact Aqua at 1-877-987-2782 or www.AquaAmerica.com for questions about service.

WATER SERVICE

Water service in East Norriton Township is provided by Pennsylvania American Water Company and regulated by the Pennsylvania Public Utility Commission. Please contact them at 1-800-565-7292 or email infopa@amwater.com for questions about service.



PERMITS

East Norriton Township follows Act 45 of the Pennsylvania Uniform Construction Code which adopted the 2015 International Code Council (ICC) code series, effective October 1, 2018. Building Codes allows us to rely on the safety of the structures around us in our everyday living. The requirement of construction permits allows the local code officials to administer the provisions of the code to ensure proper construction.

If you are planning any kind of home remodeling project, or thinking of retaining a contractor to do work for you, please keep these regulations in mind. Construction permits are needed for most repairs, additions and alterations to properties including but not limited to: roofs, siding, windows, pools, driveways, heating, air conditioning, electrical systems, etc. Permits are not required for painting, tree removal, nor replacing windows of the same size unless a structural alteration is being made. If you are unsure if a permit is required, please take the time to call Code Enforcement Department prior to beginning work at 610-275-2800.

BURNING

No open burning is permitted in East Norriton Township.

Norriton Fire Engine Company



The Norriton Fire Engine Company **protects** the residents in an area of 6.1 square miles in central Montgomery County. The Norriton Fire Engine Company was chartered on May 17, 1917 to protect the ever-growing population of East Norriton Township which is made up of hundreds of residential homes, commercial, and light industrial structures.

We are a volunteer organization made up of your neighbors. Our members serve in various roles. Most of our volunteers are firefighters, but others serve in roles such as fire police and administrative positions. Our members come from many diverse backgrounds with one common desire, to help others.

A joint effort between the fire company and the township has yielded three township employees who can respond to emergency calls during the daytime working hours. These personnel consist of the Fire Marshal, the Director of Fire Services and three Code Enforcement Officers. These individuals have the added responsibility to respond as drivers/firefighters for the fire company on weekdays. This is the time of day when most of our volunteers are at work and are not able to respond. These township employees supplement the few volunteers that are able to respond on weekdays. Evenings and weekends continue to be covered by 100% volunteers.

The Norriton Fire Engine Company has been recognized by the Fire Commissioner's Office of Pennsylvania for our firefighters being trained and certified for firefighting. Our members not only have the basic training, but strive to obtain higher levels of training, all on a volunteer basis. We have members certified both at the state and national levels for many firefighting and rescue disciplines. Besides the Montgomery County Fire Academy, our members receive training from the Pennsylvania State Fire Academy, National Fire Academy, PA Department of Health, PA and Federal Emergency Management Agencies, PA Department of Conservation & Natural Resources, PA Fish & Boat Commission, and many more agencies. Our members go the extra mile, literally sometimes, for training. We have traveled all over Pennsylvania for training, as well as New Jersey, Indiana, Maryland, and even Nevada and Colorado. We realize that training never stops. Most of our more experienced members give back to the fire service by assisting and training others.

Plymouth Community Ambulance Association (PCAA) is a 911 Emergency only, Advanced Life Support, Paramedic Ambulance Service servicing eleven municipalities and over 110,000 permanent residents. They have four busy stations in Montgomery County, PA, with a rich history. PCAA is fully licensed and accredited by the Pennsylvania Department of Health to provide the highest level of pre-hospital care available in the State. They are a designated part of the State plan for Emergency Medical Coverage for Montgomery County.

The municipalities serviced begin with “The Heart of Montgomery County” Norristown Borough, Plymouth Township, East Norriton Township, West Norriton Township, and Worcester Township. In the fall of 2014 Plymouth Community Ambulance Association and Lower Frederick Regional Ambulance Corps (LFRAC) merged. LFRAC serviced the following municipalities in the central Montgomery County region: Lower Frederick Township, Upper Frederick Township, Perkiomen Township, Schwenksville Borough, Upper Salford Township, and Limerick Township. Suburban Community Hospital and Einstein are the primary destination facilities and are both centrally located within their service area.

NORRITON Little League was created by the merger of East and West Norriton Little Leagues. Having 133 years of combined tradition, this venture is reinforced by the rich history of both leagues as we continue to support the largest youth sports organization in the world: Little League of America. Built on the tradition of America’s favorite pastime, our success is due to the dedication of its member families and its many volunteers who donate their time and talent.

In 2021 East Norriton Little League combined forces with West Norriton Little League to offer a robust recreational Little League Baseball program - NORRITON BASEBALL. Any child who resides in or whose school is within the boundaries of East or West Norriton Little Leagues is eligible for NORRITON BASEBALL. Norristown Farm Park has a variety of buildings and open fields that represent a diverse history of farming, manufacturing, and institutional associations. The buildings date from the mid-18th century through the early 20th century and at various times were part of mills, a tannery, farms, and the Norristown State Hospital. The unique and breathtaking beauty of the woods and agricultural fields, combined with a stocked trout stream, the Norristown Farm Park has it all.

Where else can a visitor bicycle, walk, hike, run, jog, picnic, fish in a stocked trout stream, walk their dog, or view wildlife in their natural habitats? The Park has over seven miles of paved trails and there are several rustic nature trails available for the adventuresome. Norristown Farm Park is right where you can do all of these pleasurable pastimes and more! We offer the following activities at the Farm Park:

Hiking, jogging, running, roller blading, skating, biking, picnicking, wildlife viewing, nature, photography, fishing, skateboarding, dog walking, and more!

The Farm Park is owned by the Commonwealth of Pennsylvania and is operated and maintained by Montgomery County. This unique relationship blends recreational opportunities and agricultural activities.

Hours: Open daily, 6 a.m. to sunset. The Farm Park is closed on Thanksgiving Day, Christmas Day, and New Year's Day.

Picnics: There are many areas throughout the park to have a picnic. Two picnic pavilions are available for use and the Salt Wing building is available for groups of up to 75 people. Groups, organizations, and individuals wishing to reserve these pavilions or the Salt Wing for their function need to contact the Park Office for dates and availability.

Schuylkill River Trail www.montcopa.org/schuylkillrivertrail



The Schuylkill River Trail in Montgomery County is an 18-mile, multi-use trail that runs from Philadelphia to Mont Clare. It was built on the Pennsylvania Railroad right of way and parallels the scenic Schuylkill River as it passes through various townships and boroughs. The trail is a popular destination for biking, rollerblading, jogging, and walking. It is recognized as a National Recreation Trail by the U.S. Department of Interior's National Trails System.

Once the remaining Pottstown portion of the trail is completed, 22.5 miles of the trail will pass through the county. Chester County is moving forward with its portion of the project, which will eventually result in the completion of a 60-mile continuous portion from Philadelphia to Reading. The long-range goal is a 115-mile trail from Pottsville in Schuylkill County to Philadelphia.

From the past to the present. From the historic river towns of Conshohocken, Norristown, and Pottstown to the rolling hills of Valley Forge National Historical Park. The Schuylkill River Trail in Montgomery County takes visitors through a rich blend of natural, cultural, and historical resources. The trail runs through a variety of urban, suburban, and rural landscapes, offering nearly 20 miles to hikers, joggers, bicyclists, equestrians, and in-line skaters.

The Schuylkill River Trail (SRT) is the spine of the Schuylkill River National and State Heritage Corridor. When completed, the trail will run over 100 miles from the coal region of Schuylkill County to the Delaware River in Philadelphia. Evidence of several centuries of industrial use remains where river and canal navigation, quarrying of limestone and iron ore, and production of iron and steel have succeeded each other as mainstays of this region's economy. Today, these industries are giving way to urban renewal, including high-rise development and riverfront restoration.

The trail provides direct connections to several other Montgomery County regional trails, including the Perkiomen Trail, the Cross-County Trail, and the future Chester Valley Trail Extension. For those seeking public transportation to the trail, SEPTA offers excellent access via regional rail service and bus lines in Miquon, Spring Mill, Conshohocken, and Norristown.
