**A RESOLUTION OF THE BOARD OF SUPERVISORS OF EAST NORRITON
TOWNSHIP APPROVING THE BUDGET AND FIXING THE
REAL ESTATE TAX RATE FOR THE YEAR 2019**

WHEREAS, the proposed 2019 Budget has been presented with the total revenue (all funds) of \$18,717,082 and total expenditures (all funds) of 18,717,082; and

WHEREAS a tax be and the same is hereby levied on all real property within East Norriton Township subject to taxation for the fiscal year 2019 as follows:

Tax rate for general purposes, the sum of	1.447	mills
on each dollar of assessed valuation, or the sum.....	.1447	cents
on each one hundred dollars of assessed valuation.		
Tax rate for debt purposes, the sum of270	mills
on each dollar of assessed valuation, or the sum.....	.0270	cents
on each one hundred dollars of assessed valuation.		
Tax rate for recreation purposes, the sum of326	mills
on each dollar of assessed valuation, or the sum.....	.0326	cents
on each one hundred dollars of assessed valuation.		
Tax rate for street lighting purposes, the sum of030	mills
on each dollar of assessed valuation, or the sum.....	.0030	cents
on each one hundred dollars of assessed valuation.		
Tax rate for fire protection purposes, the sum of.....	.288	mills
on each dollar of assessed valuation, or the sum.....	.0288	cents
on each one hundred dollars of assessed valuation.		
Tax rate for capital reserve purposes, the sum of366	mills
on each dollar of assessed valuation, or the sum.....	.0366	cents
on each one hundred dollars of assessed valuation.
