

ORDINANCE NO. 107

East Norriton Township
Montgomery County, Pennsylvania

AN ORDINANCE CREATING SEWER DISTRICT NO. 2 IN EAST NORRITON TOWNSHIP; DESIGNATING SAID SEWER DISTRICT AS A SEWER SERVICE AREA OF THE EAST NORRITON TOWNSHIP MUNICIPAL AUTHORITY AND AUTHORIZING THE CONSTRUCTION OF SEWERS THEREFOR AND THEREIN AT THE DISCRETION OF THE EAST NORRITON TOWNSHIP MUNICIPAL AUTHORITY; GRANTING RIGHTS ON, OVER AND UNDER STREETS IN SAID DISTRICT.

WHEREAS, by Ordinance No. 2 dated May 3, 1948, and by Resolution dated June 7, 1948, the Board of Supervisors of East Norriton Township created the East Norriton Township Municipal Authority, all in accordance with the Municipality Authorities Act of May 2, 1945, P.L. 382, as amended; and

WHEREAS, the Board of Supervisors by Ordinance No. 28 designated and created Sewer District No. 1 within East Norriton Township; and

WHEREAS, the Board of Supervisors deems it advisable to expand the service area of the East Norriton Township municipality to encompass the entire Township.

NOW, THEREFORE, the Board of Supervisors of East Norriton Township, Montgomery County, hereby ordains and enacts as follows:

Section 1. There is hereby created in East Norriton Township a Sewer District, to be known as the East Norriton Township Sewer District No. 2, which shall include all of East Norriton Township with the exception of that portion of East Norriton Township encompassed within Sewer District No. 1.

Section 2. The East Norriton Township Sewer District No. 2 is hereby designated as a sewer service area of the East Norriton Township Municipality Authority and the said Authority is authorized and directed to own, operate, maintain and construct sewers for and in East Norriton Township Sewer District No. 2.

Section 3. East Norriton Township hereby grants to the Authority all and every easement, right-of-way and other rights necessary or desirable on, over or under the streets within Sewer District No. 2 for the purpose of constructing sewers therein and in any easements acquired by East Norriton Township for the purpose of constructing sanitary sewer lines.

Section 4. The appropriate officials of East Norriton Township are hereby authorized to enter into such agreements as are necessary to effectuate the intent of this Ordinance.
