AN ORDINANCE AMENDING ORDINANCE NO. 49 COVERING THE DESIGN, CONSTRUCTION, ALTERATION, ENLARGEMENT, EQUIPMENT, REPAIR, DEMOLITION, RESTORATION, KNOWN AS THE BUILDING ORDINANCE: PROVIDING FOR FLOOD DAMAGE CONTROLS AND PROTECTION IN CONFORMANCE WITH SECTION 1910.3d, FEDERAL FLOOD INSURANCE PROGRAM; PROVIDING FOR THE ISSUANCE OF PERMITS, COLLECTION OF FEES; MAKING OF INSPECTIONS; PROVIDING PENALTIES FOR THE VIOLATION THERE; AND REPEALING ANY EXISTING ORDINANCES AND RESOLUTIONS OR PARTS THEREOF IN CONFLICT THEREWITH OF EAST NORRITON TOWNSHIP, MONTGOMERY COUNTY, PENNSYLVANIA.

BE IT ORDAINED by the Board of Supervisors of the Township of East Norriton, Montgomery County, Pennsylvania as follows:

- I. Ordinance No. 49 is amended to divide its various contents under articles as shown herein:
 - a. Sections I and II of Ordinance No. 49 concerning Building Code adoption and additions, insertions, deletions and changes will be included under Article I.
 - b. The provision for flood damage controls and protection in conformance with Section 1910.3d, Federal Flood Insurance Program will be included under Article II.
 - c. Sections III and IV of Ordinance No. 49 concerning repeal, validity and other items will be included under Article III.
- II. Section I of Ordinance No. 49 is deleted and replaced under Article I as follows:

ARTICLE I


SECTION I. ADOPTION OF BUILDING CODE. That certain documents, three (3) copies of which are on file in the Office of the Building Inspector of East Norriton Township, Montgomery County, Pennsylvania, being marked and designated as the "BOCA Basic Building Code" 1975 Edition and "Supplement No. 1, 1976" thereto, as published by the Building Officials Conference of America, Inc., and any current supplements thereto from time to time made and published be and are hereby adopted as the Building Code of the Township of East Norriton, Montgomery County, Pennsylvania; for the control of buildings and structures as herein provided; and each and all of the regulations, provisions, penalties, conditions and terms of said BOCA Basic Building Code 1975 Edition and Supplement No. 1, 1976 thereto and any current supplements thereto from time to time made and published as aforesaid are hereby referred to, adopted and made a part hereof, as is fully set out in this Ordinance, with the additions, insertions, deletions and changes, if any, prescribed in Section II of this Article.

- III. Section II of Ordinance No. 49 as amended by resolutions thereto, remain in effect even though identification numbers may not conform with the BOCA Basic Building Code 1975 Edition and Supplement No. 1, 1976, thereto, except that the fee schedule is deleted with such fees being prescribed from time to time by resolution, with current resolution in effect being Resolution No. 851.
- IV. Ordinance No. 133 concerning flood damage controls and protection is added to Ordinance No. 49 under Article II.
- V. Sections III and IV of Ordinance No. 49 concerning repeal and validity remain in effect under Article III.


