

ORDINANCE NO. 190

TOWNSHIP OF EAST NORRITON  
MONTGOMERY COUNTY, PENNSYLVANIA

AN ORDINANCE AMENDING ARTICLE II, ARTICLE X, ARTICLE IV OF THE EAST NORRITON TOWNSHIP ZONING ORDINANCE OF 1963 (ORDINANCE NO. 96) BY MAKING CERTAIN CHANGES AS SET FORTH IN THE BODY OF THE ORDINANCE.

The Board of Supervisors of the Township of East Norriton, Montgomery County, Pennsylvania, under and by virtue of the authority granted by the Second Class Township Code, do hereby enact and ordain:

SECTION 1. The East Norriton Township Zoning Ordinance of 1963 (Ordinance No. 96) is hereby amended as follows:

Section 200. The following definitions shall be added to Section 200.

1. Outside Vendor - A person or group of people offering goods or services for sale at a profit who are not currently licensed to operate in East Norriton Township.

2. Fund Raising Activity - Any activity, excluding volume retail sales, conducted in an IN-Institutional District whose profits are used to benefit the institution. Fund raising activities include, but are not limited to: fairs, carnivals, flea markets, meals, games, rides and athletic events.

3. Institution - Any church, school, hospital or other non-profit making organization.

4. Volume Retail Sales - Total goods, new or used, offered for sale, having a fair market value over \$1,500. or fair market value over \$500. from one source or for one item.

Section 405. The following Paragraph 3 is added to Section 405.

3. Uses accessory to an institutional district.

a. Fund raising activities conducted inside or outside a structure subject to the following regulations.

1. All licenses and permits must be obtained and all applicable fees shall be paid by each outside vendor.

2. All parking, traffic and crowd control shall be the responsibility of the Institution.
3. Signs may be erected in accordance with Section 1714 of the East Norriton Township Zoning Ordinance.
4. A list of all outside vendors participating in a fund raising activity shall be submitted to the Township by the institution prior to the start of the activity.

Section 1001. The following Paragraph 10 shall be added to Section 1001:

10. Accessory use as defined in Section 405.

SECTION II. This Ordinance shall in no other way affect, amend or modify the said Zoning Ordinance or Zoning Map.
