

ORDINANCE NO. 302

EAST NORRITON TOWNSHIP  
MONTGOMERY COUNTY, PENNSYLVANIA

AN ORDINANCE AMENDING THE CODE OF EAST NORRITON TOWNSHIP, SPECIFICALLY, CHAPTER 18 ENTITLED "MUNICIPAL AUTHORITIES" AND CHAPTER 162 ENTITLED "SEWERS". THESE CHAPTERS OF THE CODE SHALL BE AMENDED TO REPEAL THE CURRENT CAPITAL IMPROVEMENT PERMIT FEE OF ONE THOUSAND DOLLARS (\$1,000.00) PER RESIDENTIAL UNIT AND PER EDU FOR NONRESIDENTIAL PROPERTIES AND TO REPEAL THE CONNECTION CHARGE OF ONE THOUSAND SEVEN HUNDRED FIFTY DOLLARS (\$1,750.00) PER EDU. THIS AMENDMENT SHALL IMPOSE A TAPPING FEE OF THREE THOUSAND TWO HUNDRED SIXTY DOLLARS (\$3,260.00) CHARGEABLE BY THE EAST NORRITON TOWNSHIP MUNICIPAL AUTHORITY AND A TAPPING FEE OF ONE THOUSAND DOLLARS (\$1,000.00) CHARGEABLE ON BEHALF OF THE EAST NORRITON-PLYMOUTH JOINT AUTHORITY.

THE BOARD OF SUPERVISORS OF EAST NORRITON TOWNSHIP, MONTGOMERY COUNTY, PENNSYLVANIA UNDER AND BY VIRTUE OF AUTHORITY GRANTED BY THE SECOND CLASS TOWNSHIP CODE DOES HEREBY ENACT AND ORDAIN:

Section I.

The Code of East Norriton Township, Chapter 18 entitled "Municipal Authorities" is hereby amended as follows:

Section 18-10 is amended by deleting reference to "a capital improvement fee" and substituting therefore the following, "a tapping fee".

Section 18-11 is amended by deleting the first and second sentence of the existing paragraph and substituting therefore the following:

A tapping fee chargeable on behalf the East Norriton-Plymouth Joint Authority for residential units and nonresidential properties in the amount of One Thousand Dollars (\$1,000.00) shall be payable per residential unit and per EDU for nonresidential properties. Hereinafter, the amount of the tapping fee may be changed by Resolution of the Board of Supervisors of the Township as they may duly authorize and enact from time to time.

The Code of East Norriton Township, Chapter 162 entitled "Sewers" is hereby amended as follows:

Section 162-20 is amended by deleting the existing heading and paragraph and substituting therefore the following:

Section 162-20. Tapping Fee.

There is hereby imposed on each owner of property connecting to the sewer system a tapping fee of Three Thousand Two Hundred Sixty Dollars (\$3,260.00). This charge shall be due based upon the number of equivalent dwelling units to be served, regardless of the number of actual connections to the sewer system. Hereinafter, the amount of the tapping fee may be changed by Resolution of the Board of Supervisors of the Township as they may duly authorize and enact from time to time.

Section II.

All ordinances, or parts thereof, inconsistent with this Ordinance are hereby repealed.

Section III.

The provisions of this Ordinance are severable, and if any section, sentence, clause, part or provision hereof shall be held illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect the remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Board that this Ordinance would have been adopted if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

Section IV.

This Ordinance shall become effective five days from the date hereinafter set forth.
