

ORDINANCE NO. 428

EAST NORRITON TOWNSHIP
MONTGOMERY COUNTY, PENNSYLVANIA

AN ORDINANCE AMENDING THE ZONING MAP OF EAST
NORRITON TOWNSHIP BY CHANGING THE ZONING
CLASSIFICATION OF CERTAIN TRACT OF GROUND LOCATED
IN THE TOWNSHIP OF EAST NORRITON FROM BR-RESIDENTIAL
DISTRICT TO RP-RESIDENTIAL/PROFESSIONAL DISTRICT.

The Board of Supervisors of East Norriton Township, Montgomery County, Pennsylvania, under and by virtue of authority granted by the Second Class Township Code and the Municipalities Planning Code, do hereby enact and ordain:

SECTION 1. The Zoning Map of East Norriton Township is hereby amended by changing the zoning classification of the property described below from BR-Residential District to RP-Residential/Professional District.

SECTION 2. The area of the zoning map changed by this Ordinance shall be as follows:

ALL THAT CERTAIN tract or piece of land, with the buildings, and improvements thereon erected, Situate in the Township of East Norriton, County of Montgomery and Commonwealth of Pennsylvania, bounded and described as follows:
